  - New Code Compliance Inspector- James Herring (east side of West End Drive)
  - o Recent issues-
    - Cars broken into on Huron (unlocked, keys left in cars, guns left in unlocked)
    - Violent crimes increased 47% in West End of Henrico, primarily juveniles (13- 17 years old),
    - Overdoses have increased significantly
  - Henrico Police has new logo, will have new uniforms coming
