- Hurricane Fence- still need to look at and fix gate
- Membership Drive

 - o WEMCA email/letter- Craig will work on
- March 28th Membership Meeting
 - o Host in Community Building, 7pm
 - o Planning Subcommittee- Allen and Craig
 - Quick business meeting/update (not a full board meeting)
 - Provide update on where started, present vision for next year or 2 years
 - o Possible slide presentation

 - Ouestion and Answer
 - Vote on bylaws (if amended by meeting date)
 - Encourage membership/joining at meeting
- Collaborate with HCFP on food drive(s)
 - Possible events in Spring (focus on seniors) and Summer (focus on families), No dates set yet
 - 3 day event (Thursday- Saturday)- collect food, bag it, and distribute
 - Board voted to move forward with this
- Event Calendar
 - o Allen- will look into coordinating blood drive
 - Discussion of possible events/activities
 - 3 signature WEMCA events, with smaller events
 - Programs for seniors- seminars on Medicare/Medicaid, exercise programs, etc.
 - Raising money events for kitchen items, HVAC, etc.
- Building/ Property improvements
 - Dan S. will continue to work with Henrico to try to get additional funds for larger expenses
 - Expectation to use Henrico money for smaller items
 - Priority 1: Kitchen-
 - Now have: 2 stoves, 2 fridges, icemaker
 - Needs: new floor, finish wall/storage to block off kitchen,



microwave hood vents over stoves

- Need to research Health Department Guidelines
- Priority 2: Security lights (wifi and Ring camera/lights)
- Priority 3: New doors
- Other items:
 - Finish cinder block wall to match finished wall
 - Redo floor
 - Henrico PD- recommended having clear view from street to building (cutting back trees/brush)
 - Back door- removed/walled up
- Renovations in lieu of WEBC classroom trailer
 - Make storage room and office into 1 meeting room (keep window vs. board it up), Make 10x10 room out of small open section
 - Motion by Craig- get prices for renovations and discuss budget with church, 2nd by Sara
 - Bob- concerns about ensuring that there is an area for WEMCA to lock up items, possibility of using storage room or maintenance closet

Old Business

- Consider installation of additional fencing to inhibit trespassing
 - \$3,800 to get fences extended
 - Will consider other options (move stones, move gates from near dam)
- Potential use of property by non-profits
 - o Jacob's Chance will give presentation at March board meeting
