## Building and Grounds Report- John

- o Henrico County brought new ceiling tiles
- o Draining issues-
  - Dan S. will talk to Public Works about getting a ditch dug behind the building to help with drainage
  - Need to install downspout diverters
- o Cleaning- estimates for floor getting resealed-
  - Main floor needs to be stripped and waxed annually to maintain
  - SSC Service- \$1,500 for stripping and waxing the floor
    - Floor Top Scrub and waxing- Motion Bob, 2<sup>nd</sup> Jimmy and Craig,
       Discussion- Craig using Henrico funds is important to show that we are utilizing, Passed and Approved
    - Would honor \$200 cleaning fee
    - Motion to switch from Mr. Taylor to SSC Service for cleaning by Craig, 2<sup>nd</sup> Bob, No discussion, Approved

- Presentation by WEBC concerning desired renovations- Brandon Bishop
  - Ticket Room and Office Remodel Proposal-
    - Need for space for children's services (kid's club) and nursery
    - Discussed benefits
    - Discussion of scope of work
    - Discussion of bids from 2 contractors
      - Additional expenses
        - project contingency
        - Flooring
        - o Door
      - Discussion of Cost Sharing
      - Jimmy- recommendation to get references and examples of contractor's work before agreeing to contractor
      - Any contract would be signed by WEMCA, not church
  - o Discussion of Lease-
    - Longer term on the lease to help with development of the construction project (12- 18 months)
  - Discussion of memorandum (will sign contract and pay half permitted they will sign 2 year lease, plus additional lease to get until January)
